Sub: Directions under section 33A of the Water (Prevention & Control of Pollution) Act, 1974.

This is without prejudice to the right of Rajasthan State Pollution Control Board (herein after referred to as 'the Board') to initiate proceedings under the various provisions of the Water (Prevention & Control of Pollution) Act, 1974 (herein after referred to as "Water Act") for violation of provisions of the Act here-in-after shown:-

1. Whereas, the Water Act has come into force in whole of State of Rajasthan with effect from 23.03.1974.
2. And whereas, the said Water Act has been enacted to provide for prevention & control of water pollution and for maintaining & restoring the wholesomeness of water.
3. And whereas, keeping in view, the Board has been conferred power to take such steps as are deemed necessary for prevention, control and abatement of water pollution.
4. And whereas, section 24 of the Water Act provides that no person can cause or permit any poisonous, noxious or polluting matter, determined in accordance with such standards as may be laid down by the State Board, to enter into any stream or well or sewer or on land.
5. And whereas, the industry is being operated and engaged in textile processing and the process is such that it generates polluted trade/domestic effluent.
6. And whereas, the Consent to Operate was issued to the industry by the State Board with the conditions mentioned therein.
7. And whereas it has come to the notice of this Board that multiple complaints have been received regarding the illegal discharge of industrial effluent by certain units operating in Bhilwara, either within their premises or outside the premises.
8. And whereas, the above stated non-compliances and violations have been viewed seriously by the State Board.
9. And whereas, the State Board may, in exercise of the powers conferred upon it under the provisions of Section 33A of the Water (Prevention & Control of Pollution) Act 1974 and performance of its functions under said Act, issue directions in writing to any person, officer or any authority and such person, officer or authority shall be bound to comply with such directions.

Now, in order to prevent further non-compliance with the provisions of the Water (Prevention and Control of Pollution) Act, 1974, the State Board, in exercise of the powers conferred upon it under Section 33A of the Water Act, **you are hereby directed to ensure the compliance of the following:-**

- a) Strictly maintain Zero Liquid Discharge (ZLD) status inside and outside the premises.

- b) Ensure that no untreated or treated effluent is discharged outside the premises into drains, stormwater channels, sewer lines, water bodies, or in open land.
- c) Properly operate and maintain Effluent Treatment Plants (ETPs) and ZLD systems.
- d) Maintain complete records of effluent generation, treatment, recycling, and disposal of hazardous waste, and make them available for inspection as and when required.
- e) Immediately rectify any deficiencies in treatment systems, if observed.
- f) No effluent/RO Reject shall be disposed/transport through the tankers.

Please note that the non-compliance of the above directions may compel the Board to initiate punitive action as per provisions of Water Act, 1974, as amended till date, which may include revocation of Consent to Operate and/or closure of the industry without giving any further opportunity of being heard. These directions shall be treated as the final opportunity of being heard in above mentioned violations.

This bears approval of competent authority.
